1. The supply of the materials will be received at concerned Archaeological site.
2. The tenders not accompanied with earnest money of the work in the form of Demand Draft in favour of the Superintending Archaeologist, Archaeological Survey of India, Patna Circle, Patna will be summarily rejected.
3. The tender form for the work can be received from the office of the Superintending Archaeologist, Archaeological Survey of India, Patna Circle, J.C. Road, Patna on all working days upto **4.00 PM from 11.01.2016 to 15.01.2016** against cash payment of Rs.500/- each (non refundable)
4. The cost of tender form (if downloaded from website) in the form of Demand Draft in favour of S.A., A.S.I., Patna Circle, Patna should be enclosed alongwith the tender form which should reach to this office within the stipulated period.
