TERMS & CONDITIONS

1. The supply of the materials will be received at concerned Archaeological site.
2. The tenders not accompanied with earnest money of the work in the form of Demand Draft in favour of the Superintending Archaeologist, Archaeological Survey of India, Patna Circle, Patna will be summarily rejected.
3. The tender form for the work can be received from the office of the Superintending Archaeologist, Archaeological Survey of India, Patna Circle, J.C. Road, Patna on all working days upto **4.00 PM from 22.02.2017 to 28.02.2017** against cash payment of Rs.500/- each (non refundable). The date of D/D should be after publication of tender.
4. The cost of tender form (if downloaded from website) in the form of Demand Draft in favour of S.A., A.S.I., Patna Circle, Patna should be enclosed alongwith the tender form which should reach to this office within the stipulated period.
5. The supplier have to produce the Registration Certificate, PAN No., experience certificate of at least 2 years of supplier, Sale Tax Clearance Certificate, TIN Certificate & Character Certificate for obtaining the tender paper.
6. The concern suppliers will submit the attested photo state copy by any Gazetted Officer of all relevant paper during the filling of tender form.
