

SHORT TERM TENDER NOTICE

Road, Patna invites tender from approved & two years experienced supplier registered with the CPWD, Railways, P & T Department, M. E.S., Local PWD, Irrigation Department etc. for single-handedly supply of all the items as per specification, **up to 3.00 P.M of 04.11.2015**, which will be opened on the same day at **3.30 PM**, in the office of the Superintending Archaeologist, Archaeological Survey of India, J.C. Road, Patna Circle, Patna. Details of supply of materials are given in the tender form.
