Provision of providing and fixing wooden guard rails, cutting hole in pathway and fixing each wooden post (100/100mm) is to be neatly inserted into the brick on edge pathway at a centre to centre distance of 1200mm and clear height of 900 mm from floor level. Two horizontal members are to be provided in the form of a top rail (cross section 100/50mm) and a mid-rail/separator (of cross section 75/50mm) between 2 successive posts. Each post is to be provided with double layered square wooden base measuring (200/200mm) with rounded comers. The base is to be made heavy to ensure stability and in no circumstances should nails be visible with the cost of material and labour cost all complete.
