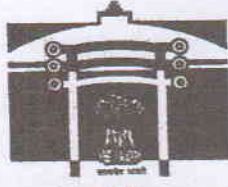

3.Terms and Conditions:

- (i) Bids should be accompanied by Earnest Money of Rs 2000/- (Rupees two thousand only) in the form of Demand Draft (DD) drawn in favour of Superintending Archaeologist, ASI , Excavation Branch- III, Patna drawn on any nationalized bank payable at Patna, without which the bids will not be considered. The Demand Draft along with the sealed bids should be put together in an envelope superscribed "Bid for sale of one number condemned vehicle" and send/submitted to the address as indicated above.

- (ii) The bidders will not be allowed to withdraw their bids, failing which their Earnest Money Deposit (EMD) will be forfeited.
- (iii) The opening of tender will be immediately followed by bidding.
- (iv) In the event of acceptance of bids, the successful bidder (i.e., highest bidder) will be required to deposit the full bid amount by means of DD/Cash drawn in favor of Superintending Archaeologist, ASI, Excavation Branch-III, Patna payable at Patna immediately after closing of Bid.
- (v) The Earnest Money Deposit (EMD) of the successful bidder will be released only after the deposit sale proceeds. The EMD will not be adjusted as sale proceeds and it will be forfeited in case failure in honoring the bid. In all cases, no interest will be paid on EMD.
- (vi) The successful bidder will also be responsible for getting the Registration Certificates of the vehicle transferred in his name (if/as necessary/required by law) at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- (viii) The vehicles will be delivered only after the receipt of full payment as well as submission documentary evidence in support of residential status (Aadhar /Voter ID card/Passport in case individual and Registration Certificate in case of firms) and the challan / money receipt of DTO regarding application for transfer of ownership. The sold vehicles have to be lifted at the successful bidder's own expenses within seven days of final payment beyond which this office will not be responsible either for safe custody or for any loss or damage to the said vehicles.
- (vii) The vehicles will be disposed off on "as is where is" basis and no guarantee for its worthiness of quality will be given by this office.
- (ix) Legal dispute if any will be subject to Patna Jurisdiction only.

All the bidders undertake to abide by the additional terms and conditions (if any) as would be lay down by the competent authority from time to time.
